# 2004 Report Of The Executive Director Of The APEC Secretariat To The Sixteenth APEC Ministerial Meeting

Purpose: Consideration Submitted by: APEC Secretariat Forum Doc. No.: 2004/CSOM/005

#### **Executive Summary**

The Report of the Executive Director of the APEC Secretariat to the 16<sup>th</sup> APEC Ministerial Meeting represents the Executive Director's annual performance accountability statement to Ministers. This has been a commitment and practice since 1999.

From the conclusion of the 15<sup>th</sup> APEC Ministerial Meeting and the 11<sup>th</sup> APEC Economic Leaders' Meeting in October 2003 in Bangkok, Thailand, the APEC Secretariat has continued to provide advisory and logistical support services to the APEC process. This service has been provided in accordance with its mandate as approved by Ministers and the 2004 Operational Plan as endorsed by Senior Officials during SOM I. The Report outlines specific service targets and outputs for 2004 covering the following headings:

- 1. Logistic and advisory support to APEC Fora;
- 2. Support to the SOM Chair;
- 3. Management of the APEC Operational and TILF accounts
- 4. Communications and Public Affairs/Information Services; and
- 5. APEC Project Evaluation

In general the report shows that the Secretariat has exceeded in many ways the scope of the job originally assigned. Overall, the APEC fora are now better served by the professional and efficient support delivered by the seconded and permanent staff, an improved communications system and a wide reaching media liaison support.

The Report concludes that the APEC Secretariat has functioned well and with fiscal efficiency. Nevertheless, in the spirit of contributing to the APEC Reform the whole operation of the APEC Secretariat has been under self-scrutiny to consider areas in which it may be advisable to introduce some changes. These observations have been presented throughout the year both orally and in writing.

#### Recommendations

1. It is recommended that **AMM** endorse the *Report of the Executive Director of the APEC Secretariat to the 16<sup>th</sup> APEC Ministerial Meeting*.

# 2004 Report of the Executive Director of the APEC Secretariat to the Fifteenth APEC Ministerial Meeting

### Santiago, Chile 17-18 November 2004

#### **EXECUTIVE DIRECTOR'S OVERVIEW**

With the approval of the Informal SOM of December 2003, and in the spirit of assisting with streamlining the SOM process, beginning in 2004 the APEC Secretariat has modified its reporting commitments. Following the submission and approval of the 2004 APEC Secretariat Operational Plan during SOM I, the Secretariat brought to the attention of SOM II and SOM III only those issues that required a decision or guidance. As agreed, this Concluding SOM is the opportunity whereby the Executive Director shall provide performance accountability to Senior Officials and to Ministers.

From the conclusion of the 15<sup>th</sup> APEC Ministerial Meeting (AMM) and the 12<sup>th</sup> APEC Economic Leaders Meeting (AELM) in October 2003 in Bangkok, Thailand, the APEC Secretariat has continued to provide advisory and logistical support services to the APEC process. This service has been provided in accordance with its mandate as approved by Ministers and the *2004 Operational Plan* as endorsed by Senior Officials. The 2004 Operational Plan appears as **Annex A**.

In accordance with the 2004 Operational Plan, the specific service targets and outputs have been served throughout 2004 as follows:

- Permanent support and assistance has been provided for the implementation of the Individual Action Plan (IAP) Peer Review process. Lessons learnt from previous reviews have been incorporated to strengthen the process. As a consequence a revised IAP Peer Review guideline has been adopted allowing for more efficient Peer Review Sessions. Furthermore, we have now concluded 14 IAP Peer Reviews and are set to complete Peer Reviews for all member economies by SOM I, 2005, in time for the 2005 Mid-Term Review, as instructed by Ministers.
- Continuous implementation of the 2001 APEC Communications and Outreach Strategy has resulted in an extended range of communications services and support provided to fora and economies to help publicise the activities and achievements of APEC and to strengthen overall coordination of effort. APEC's overall media profile has been boosted substantially during 2004 and surveying of media groups during the year has revealed a noticeable increase in both the quality and extent of reporting on APEC activities.
- Revision of existing APEC operational and project guidelines to supplement with additional policies and guidelines in the areas of communications, sponsorship and intellectual property rights. In this connection, a set of APEC Sponsorship Guidelines have been agreed, publication policy guidelines have been updated and a set of APEC Intellectual Property Guidelines are being developed.

- While providing advice on project proposals at various levels of development and managing the process of approval of urgent project proposals, commenced a review of the *Guidebook on APEC Projects* that will incorporate the outcomes of a joint ESC BMC initiative to improve evaluation through the adoption of a Quality Assessment Framework and a review of reimbursement procedures conducted by external consultants.
- Ensured a high level of service and included two new quality objectives to its ISO 9001: 2000 Quality Management Certification. Over the course of 2004 the Secretariat successfully underwent a total of four ISO Audits (two internal and two external). Still, in an ongoing process of improvement, the Secretariat continued to review its Operational Manual to ensure that its policies, procedures and guidelines remain relevant.

As an organisation staffed mainly by secondees from member economies, the APEC Secretariat has functioned well and with fiscal efficiency. Nevertheless, the Secretariat needs to continually adapt to the APEC process that it serves. Furthermore, as APEC's stature as a cooperative process grows, it is increasingly being asked to participate in activities of other regional and international organisations. At the same time, the role of the Secretariat is shifting and with it a demand for more specific qualifications from its staff is becoming necessary. Therefore, it is reasonable to consider that discussions on APEC reform should include the APEC Secretariat to adapt it as necessary to the new circumstances in which the Secretariat operates.

It has been an honour to serve as the head of an organisation that exists to serve APEC's member economies in the best possible way, providing low profile but essential services to ensure the effectiveness and smooth running of the APEC process.

#### **SECTION A – SECRETARIAT OUTPUTS**

#### Output I: Logistical and Advisory Support to APEC Fora

- Provided logistical and advisory support to over 100 meetings/activities of APEC fora including ministerial meetings for Science and Technology, Education, Trade, Mining, Finance, Energy, Small and Medium Enterprise, Tourism, Transport and the APEC Joint Ministerial Meeting.
- Provided coordination and support for the strengthened IAP Peer Review Process conducted during 2004 for Chile, China, United States, Perú, Singapore and Chinese Taipei. Further measures were implemented to allow the 2005 process to proceed according to schedule.
- Assisted the setting up of several new APEC for a including the Non Ferrous Metals'
  Dialogue, the Health Task Force, the Expanded Dialogue on Trade Facilitation and
  the Anti-Corruption Experts' Task Force. Provided coordination and logistic support
  in preparation of the Steering Group Meeting that launched the fourth APEC
  Industrial Dialogue on non-ferrous metal.
- Coordinated the process of developing an electronic management tool for SOM (temporarily called "the SOM Tasking Database") requested by Senior Officials at I SOM 2004, including its design, preparation of the request for proposals, selection of vendor and managing the consultation process with economies.

#### Highlights of the support provided to APEC for ainclude:

- The APEC Secretariat Less Paper Meeting System. Developed in APEC 2003 has been continuously updated and has supported a total of 6 meetings including BMC, IST and CTTF, over the last year. Changes were made to reduce the turnaround time in uploading of meeting materials, which has greatly enhanced the usability of the system. The system could contribute to APEC 2005, if requested.
- Provided support to APEC fora in accordance with the agreed division of responsibilities between APEC fora and the APEC Secretariat, to ensure a more standard expectation of the level of support that the Secretariat is capable of providing to fora;
- Continued to revise and tune the APEC for annual reports on the standard reporting template introduced last year in order to continue to simplify the for areporting burden and duplication;
- Coordinated the ABAC 2003 Recommendations and APEC Actions Matrix as seen in **Annex N**;
- Drafted the 2004 Committee on Trade and Investment (CTI), Economic Committee (EC) and SOM Committee on ECOTECH (ESC) reports to Ministers.

The APEC Secretariat also had the honour of welcoming the visit of the President of Chile, H.E. Ricardo Lagos. During a ceremony held in his honour, President Lagos outlined plans for APEC 2004 and the growing links between Chile and Asia. The Secretariat had earlier hosted H.E. Vice President Arturo Vallarino of Panama as well as several personalities and groups as part of its ongoing interaction with officials from member economies, as well as its outreach programme. More detail is given in Section C, Service IV.

#### Output II: Support for SOM Chair

- Provided advice and support to the APEC 2004 SOM Chair on the preparation and hosting of Senior Officials, Ministerial and Leaders Meetings.
- Prepared the draft *APEC 2003 Tasking Statement*.
- Prepared the draft annotated agenda, draft expanded annotated agenda, draft Chair's Summary Conclusions and other substantive documents for the above-mentioned meetings.
- Provided guidance and on-site operational support for management of documentation operations for SOM, Ministers Responsible for Trade and other Ministerial Meetings.
- Processed non-member participation requests/proposals. A detailed record on participation issues is attached as **Annex B**.
- Lent considerable communications expertise and support throughout the year to the host economy, to assist in multiplying both domestic and international profile-building efforts for the 2004 APEC programme of events.

#### Output III: Management of the APEC Operational and TILF Accounts

The APEC Secretariat has provided ongoing support and advice to Project Overseers, including organising tendering, negotiating contracts and reimbursement for APEC funded projects in accordance with the 5<sup>th</sup> Edition of the Guidebook on APEC Projects and the ISO 9001: 2000 Quality Management System. The Secretariat has commenced a review of the Guidebook on APEC Projects. The review will incorporate into the Guidebook the outcomes of a joint ESC – BMC initiative to improve evaluation through the adoption of a Quality Assessment Framework and a review of reimbursement procedures conducted by external consultants.

The Secretariat managed preparations for the Budget and Management Committee (BMC) meetings in March and August 2004 and provided advice on project proposals seeking reprogramming, additional funding and new funding.

Inter-sessionally, the Secretariat managed the process of approval of urgent project proposals, acting as an intermediary between project proponents and BMC members, and also between the SOM Chair and the BMC.

The Statement of Accounts for the Operational and TILF Accounts is included under Service II below.

#### Output IV: Communications and Public Affairs / Information Services

The Secretariat continues to extend the range of communications services and support provided to fora and economies to help publicise the activities and achievements of APEC and to strengthen overall coordination of effort.

Strategic advice from the Secretariat is now routinely sought by fora in the planning and execution of communications related projects as well as in the development of promotional and editorial material. The Secretariat has also lent considerable communications expertise and support throughout the year to the host economy Chile, to

assist in multiplying both domestic and international profile-building efforts for the 2004 APEC programme of events.

#### **Media Relations**

During the year the Secretariat provided on-the-ground media liaison support for all Senior Officials Meetings and major Ministerial Meetings including the Trade, Science and Technology, Tourism, SMEs and Mining Ministerial Meetings as well as the Secure Trade in the APEC Region (STAR II) Conference, CSOM and forthcoming, AMM and AELM. Assistance with managing media and publicity requirements is now being regularly extended by the Secretariat to all APEC fora and economies for major meetings, events and projects to help generate news opportunities.

APEC's overall media profile has been boosted substantially during 2004 through increased Secretariat output of information and material targeted directly at both general and specialist media outlets and surveying of media groups during the year has revealed a noticeable increase in both the quality and extent of reporting on APEC activities.

#### **APEC Website and Online Services**

The APEC website remains a key delivery mechanism for information about the APEC process to stakeholders and the public. Building on the successful development of the new site last year, a number of new services were added in 2004 as well as new content areas reflecting APEC's evolving agenda.

In late 2003, the APEC Secretariat acquired the URL - <a href="www.apec.org">www.apec.org</a>. This new URL provides APEC with a more intuitive address for its primary website, enabling both users and search engines to easily find the new site. APEC Secretariat e-mail addresses were brought into line with the new URL in early 2004.

The APEC e-newsletter was launched in December 2003 via e-mail delivery to a subscription database of businesses, academics, government officials and interested members of the public. Each issue provides analysis of APEC's activities and the tangible benefits accruing from discussion and decisions reached in the forum. Since the initial issue, two further issues have been distributed; in March and August 2004. A fourth issue is planned for December 2004.

In support of increased media activity throughout the year, the APEC website has played host to a number of webcasts throughout 2004. This includes a live webcast of President of Chile, H.E. Ricardo Lagos' address at the APEC Secretariat in May 2004, and recorded webcasts of opening addresses and press conferences of a number of key APEC meetings throughout the year.

As a trial, electronic bulletin board functionality was added to the APEC website in September 2004 to provide a web-based mechanism for information sharing and dialogue among members. Designed to allow private, member-driven communication within a virtual group, APEC Bulletin Boards (BBS) are intended to support intersessional communication by interested APEC fora. From September 2004 until January 2005, the Government Procurement Experts' Group and an informal group on Business Outreach will each trial an APEC BBS. After assessing technical and management issues associated with the trial, BBS could be offered to other interested fora in early 2005.

An FTAs/RTAs Matrix has also been created for access via the FTA/RTA page on the APEC website <a href="http://apps.apec.org/apec/fta.html">http://apps.apec.org/apec/fta.html</a>.

Summary statistics for the website are attached as **Annex C**.

#### Outreach

Outreach requirements continue to expand and the APEC Secretariat has been increasingly active in working with fora in designing communications and outreach tactics and strategies as well as identifying and responding to generic promotional opportunities for APEC.

Trips with an outreach focus were made by the Executive Director (ED) to New Zealand, Chinese Taipei and Peru. These involved a range of activities engaging with key groups from the business sector, media, the academic community and government agencies to promote the work of APEC and encouraging greater involvement and input into the APEC process. The visit to Peru also served to support Peru's early efforts in publicising its role as APEC host economy for 2008.

The Deputy Executive Director and Professional Staff Members at the Secretariat also supported outreach efforts by speaking at numerous international meetings and events throughout the year and delivering presentations to government, business and student groups visiting the Secretariat.

A list of outreach activities undertaken by the ED, DED or by Professional Staff Members during the year appears as **Annex D**.

Responding to the need to engage more effectively with the business community and to better communicate APEC's relevance and the value of the process to business, a Business Outreach Strategy was also prepared this year and several activities were implemented. These include -

- Business Editorial Program: Several editorial pieces were prepared for placement in regional business and in-flight magazines, providing practical examples to support and illustrate that APEC is relevant and produces outcomes that are important for business.
- Business Outreach Bulletin Board: An electronic bulletin board was developed for the APEC website to facilitate communication on business outreach issues between the Secretariat, economies, fora and ABAC.
- Database of Business Associations: A database of business associations and business media throughout APEC has been developed to support the periodic delivery of business-relevant information.

#### **Communications Policy and Best Practice**

To support the adoption of best practice across various areas of APEC communications activity, the Secretariat is developing as set of APEC Intellectual Property Guidelines for SOM approval and is also working with the Health Task Force on the development and testing of a set of Health Crisis Communications Response Guidelines.

#### **Production of General Information Resources on APEC**

The Secretariat produced and distributed a wide range of publications during 2004 as part of its publishing programme including promotional brochures and a variety of reports, studies and other annual publications on behalf APEC fora.

The Secretariat has recently trailed a joint publishing arrangement with leading academic and professional publisher World Scientific Publishing, which is headquartered in Singapore. The arrangement offers the potential for APEC to improve the editorial quality as well as audience reach of its publications through access to the company's professional editorial capabilities as well as its extensive distribution and marketing channels.

A review of all publications produced under the APEC banner has also been initiated to identify opportunities for greater quality control and cost effectiveness.

The lists of publications produced and supported by the Secretariat; and sales revenue received during 2004 appears as  $\underline{\mathbf{Annexes}}\ \mathbf{E}\ \mathbf{and}\ \mathbf{F}$ .

#### Output V: APEC Project Monitoring and Evaluation

- The Secretariat assisted the BMC to monitor ongoing APEC projects and to evaluate completed APEC projects.
- The Secretariat is assisting the ESC and the BMC to refine a project evaluation framework. It is expected that when completed this project evaluation framework will be integrated into the revised *Guidebook on APEC Projects* and be ready for implementation for the 2005 project cycle/budget year.

#### **SECTION B: SPECIFIC OUTPUT TARGETS FOR 2004**

- A. To support and provide assistance for the implementation of the strengthened IAP Peer Review Process. In 2004 there were IAP Peer Reviews for six (6) economies: Chile, China, Peru, Singapore, Chinese Taipei and United States. The APEC Secretariat facilitated the preparation for the IAP Peer Reviews by applying the Guideline; assigned PSMs as members of the review teams and, arranged the Peer Review Sessions. The APEC Secretariat has also taken measures to ensure the Peer Review Process for seven member economies whose sessions are to be held at SOM I, 2005, by appointing and contacting the Experts approved by SOM and designating PSMs to serve as members of the review teams. The APEC Secretariat also submitted the revised IAP Peer review guideline, which aims to make the Peer Review Session more efficient. The new format of IAP Peer Review Session was applied during the Sessions held at SOM II, 2004.
- B. <u>To continue assisting SOM in its efforts to undertake a broad APEC Reform</u>. The Secretariat introduced changes in the timeline of its reporting to SOM to assist in streamlining the SOM Meetings process. It also contributed papers with suggestions to I SOM and SOM III, as well as to the BMC.
- C. To implement and introduce further improvements to the APEC Communications and Outreach Program for 2004 with emphasis on the following areas:
  - Communications planning and support services to host economy;
  - Engagement with fora on development of fora-specific communications plans and tactics to improve outreach to key audiences;
  - Develop and implement business outreach strategy and strengthen networks with business community;
  - APEC Health Crisis Communications guidelines;
  - Media relations and information program;
  - Further extend APEC Internet presence through expansion of web-based information and communications services;
  - Extend range of generic communications resources and tools.

Communications services and support to both fora and economies have expanded considerably and all of the areas highlighted above have been addressed this year, as outlined in the main body of this report.

- D. To continue implementation of processes certified under the ISO 9001: 2000 Quality Management Certification and ensure that the ISO quality of service mentality takes a firm hold in the Secretariat.
  - The ISO Committee has included two new quality objectives with effect from September 2004: BMC pre-meeting project papers to be uploaded to website 10 days before the meeting and Substantive (papers requiring decisions) Secretariat papers for SOM/BMC to be submitted at least 10 days before the meeting.
  - Over the course of 2004 the Secretariat underwent a total of four ISO Audits; two were conducted by the Internal Audit Team consisting of Secretariat volunteers trained in the process, and two external audits which were conducted by Lloyds.
  - In an ongoing process, the Secretariat continues to review its Operational Manual to ensure that its policies, procedures and guidelines remain relevant.

- E. Keep under review the strategy developed in 2001 to address the potential financial problems relating to the forecasted expenditure for year 2004, without increasing members' contributions. To consider means to expand the financing of project proposals, bearing in mind the current number and amount of contributions to the TILF Special Account; to seek Members' views and report on progress. The APEC Secretariat has continued to keep updated the forecast of expenditure for the Administrative and Operational Accounts and echoed calls for additional contributors to the TILF Special Account. The BMC has agreed that the current financial strategy should remain in place for 2005, but changes will be required from 2006 onwards. The Secretariat has prepared papers on these changes for discussion at the BMC at meetings and intersessionally and also for discussion at SOM. Following these discussions the Secretariat is examining further options and examining critically its expenditure in relation to the agreed taskings and whether there should be changes to those taskings. Further papers are being prepared.
- F. To continue with the design, development and maintenance of the SOM Database on Implementation of APEC Commitments.

  Later called "the SOM Tasking Database", the Secretariat has coordinated the process of developing an electronic management tool for SOM requested by Senior Officials at I SOM 2004, including its design, preparation of the request for proposals, selection of vendor and managing the consultation process with economies. It has reached the stage of presenting a demonstration model to allow for further consideration by SOM.
- G. To improve the process of approval for APEC participation in non-member activities ensuring appropriate representation and outreach. To propose to SOM a guideline that properly considers the needs of representation and outreach. The Secretariat developed and proposed to SOM a Guideline that it understands properly considers the needs of representation and outreach. The Secretariat stands ready to further contribute to the decision making process currently in the hands of SOM.
- H. To contribute to SOM with the review of the experience gained in terms of capacity building identifying measures and practices that may contribute to improve WTO capacity building activities.
   The Secretariat provided its assistance and logistic support for the preparations of the Seminar on WTO Capacity Building Best Practice and took all the measures available to disseminate its outcomes.
- I. To contribute to the timely completion of preparations to conduct a successful mid-term stocktake in 2005 on overall progress towards meeting the Bogor Goals. The APEC Secretariat has readily provided information to SOM on the past review practice and given advice to Korea, incoming host economy, for the financial rules to apply for the TILF project titled "Mid-term stocktaking of the progress towards the Bogor Goals." Furthermore, the APEC Secretariat is ready to support member economies to prepare for the Mid-term Stocktake review.

J. To contribute to the trade facilitation process through the compilation of information about best practices and propose a project so that it may be made available in local languages of APEC.

In 2004, the Secretariat provided extensive support to the Expanded Dialogue on Trade Facilitation that was organized by CTI and ABAC on 1 October 2004. The Dialogue served to assess whether APEC was on track to meet the Shanghai Accord's target of reducing transaction costs by 5 percent by 2006. An outside expert was commissioned by CTI to perform an assessment of APEC's implementation of the Trade Facilitation Action Plan (TFAP). The assessment was based on 2004 IAP Highlights of Trade Facilitation cum MidTerm Review report submitted by economies and other related APEC documents. The results of this assessment will be published and presented to AMM and made publicly available through the APEC Homepage. In addition, the Secretariat has also worked with the e-IAP system developer to "house" the 2004 Mid-term review Trade Facilitation reports.

K. To assist in further refining the template for reporting the implementation by economies of the General Transparency Standards and make these standards publicly available to the business community.

The Secretariat supported the CTI in the updating of the IAP chapter templates to reflect the sector-specific transparency standards in 9 areas: services; investment; competition law and policy and regulatory reform; standards and conformance; intellectual property; customs procedures; market access and government procurement as well as the development of a new template on APEC's general transparency standards. The Secretariat will explore how best to incorporate these templates into the reporting structure of IAPs in the e-IAP system.

The Secretariat will also continue to assist the CTI in its work with ABAC and the wider business community to develop a list of concrete transparency-related issues that are important to the private sector in specific APEC economies.

L. <u>To assist SOM on the identification and implementation of capacity building</u> projects under the four ECOTECH priorities.

Using the existing management mechanisms, the Secretariat supported the ESC in identification and coordination of ECOTECH activities across Working Groups and Fora. These activities are reported in the 2004 SOM Report on Economic and Technical Cooperation.

The Secretariat also supported the ESC in strengthening the implementation of ECOTECH activities through an independent assessment of the Fisheries Working Group (FWG) and the improved project evaluation frameworks. The latter has led to the development of a new Quality Assessment Framework (QAF) which will replace the existing ECOTECH Weightings Matrix that forms part of the APEC Project Proposal Format from next year. It will also continue to support the ESC and Working Groups in avoiding duplication of works by providing information on past and existing ECOTECH projects through a revamping of the APEC Secretariat Project Database to be completed in 2005.

M. To ensure that APEC's communication strategy promotes APEC's counterterrorism initiatives to its stakeholders. The Secretariat has worked closely with CTTF throughout the year to continuously promote APEC's efforts in countering the economic effects of terrorism and in promoting secure trade. This has included generating media exposure through interviews and news releases and insertion of content on this important topic in key speeches, editorial and published material.

# SECTION C – INTRA-SECRETARIAT SERVICES REQUIRED TO PRODUCE OUTPUTS

#### Service I: Communications and Information Services

#### **Information Technology**

Information and communications technology continues to be critical to the work of the Secretariat and requires substantial resources. Starting in 2003 and continuing in 2004, a number of projects were undertaken to improve the IT system and to ensure that it maximises the efficiency of the Secretariat's operation and APEC in general.

- Less Paper Meeting System The Secretariat developed the APEC Secretariat Less Paper Meeting System in 2003, now used to support meetings held in Secretariat. The updating and improvements of this system demonstrates the continual effort taken by Secretariat in providing innovative initiatives in supporting the APEC process.
- Wireless LAN (Local Area Network) The Secretariat has put in place a wireless LAN infrastructure within the APEC Secretariat building. This forms the backbone which supports applications such as the Less Paper Meeting System.
- Firewall Installation of a firewall has allowed the monitoring of network traffics accessing valuable information assets of APEC web server and email system. This has improved the administrator's capability in defending Secretariat's systems against Internet threats such as denial of service.
- Fax Gateway This was installed to facilitate the ease of disseminating information on APEC activities to media contacts by the communications team.
- Security Awareness Programme All staff members attended a specially tailored inhouse training course to increase their level of awareness in computer security.
- The Secretariat Web server The Secretariat has upgraded the APEC Secretariat web server system having high performance and capacities as well as reliable web services
- Upgrading of mail server which provide a more robust communication tool to Secretariat, it also comes with features that allow Directors on the move to efficiently communicate with their counterparts and Secretariat.
- Inclusion of Trade Facilitation and APEC Food System into the e-IAP system.
- Adopt a new purchase mean by leasing notebooks instead of upfront purchases. This allows Secretariat to spread investment of substantial amount over 2 to 3 years and to ensure Secretariat Directors having up-to-date equipment to carry out their works efficiently.

#### **Management of APEC Documentation Policy**

The Secretariat continues to improve and strengthen its management of APEC documentation in line with the document access policy including through the application of ISO 9001: 2000 quality management processes.

During 2004 the Secretariat assisted with the transfer of expertise and knowledge in this area to the host economy through onsite support at meetings as well as training given to staff involved with documentation management both from the host economy as well as the incoming host economy, Korea (2005).

#### Service II: Management of the APEC Central Fund

The Secretariat manages three accounts under the APEC Central Fund - the Administrative Account, the Operational Account and the TILF Special Account. The following financial report covers all these accounts.

#### Financial Report for the Period Ending 31 August 2004

#### 1. Asset Status

The Secretariat maintains all assets in deposits, most in the form of US dollar fixed deposits. Members' contributions are made in US dollars. Eventual disbursements to approved projects are also mostly made in US dollars. Singapore-dollar denominated expenditures are required for the majority of the local costs of the APEC Secretariat. The relevant US dollar accounts are drawn upon and converted to Singapore dollars when such expenditures are necessary.

As at 31 August 2004, the total assets under the Operational and Administrative Accounts were as follows:

#### 2. Revenue

The total revenue for the period 1 January to 31 August 2004 for the Administration and Operational Accounts was US\$2,423,000 (Annex G). Contributions from Member economies are required to be deposited in the APEC Central Fund by 31 March each year. The tendency for some economies to make their contributions late is becoming more marked. This could prove disruptive to the operations of the APEC Secretariat and Operational Account projects in future years. There is also still one contribution of US\$50,000 still outstanding from 2003. The APEC Secretariat is actively following up the economies which have not yet paid.

The total revenue from 1 January to 31 August 2004 under the TILF Special Account was US\$2,981,800 (Annex H).

#### 3. Expenditure

**Operational Account** 

The total approved amount under the Operational Account for 2000, 2001, 2002, 2003 and 2004 projects was US\$10,207,000. The APEC Secretariat had, up to 31 August 2004, disbursed a total of US\$5,899,800 (57.8%) (Details are at **Annex I**).

#### TILF Special Account

The total approved amount under the TILF Special Account for 2000, 2001, 2002, 2003 and 2004 projects was US\$24,601,800. The Secretariat had, up to 31 August 2004, disbursed a total of US\$12,090,200 (49.3%) (Details are at **Annex J**).

#### Administrative Account

The Administrative Account covers the costs of running the APEC Secretariat Office in Singapore and the production of Operational Plan outputs. In 2004, the Secretariat continues to exercise prudence and tight control in managing this account. The expenditure incurred from 1 January to 31 August 2004 was US\$1,337,500 (38.2%) (Details are at **Annex K**).

#### 4. Uncommitted Reserves

The uncommitted reserves are the total funds under the management of the APEC Secretariat which are not committed by the BMC for any specific purpose at a specific point of time. These reserves consist of members' contributions, savings from expired and cancelled projects, bank interest and any other income, minus all the committed expenditures.

The uncommitted reserves for the Administrative and Operational Account as of 31 August 2004 amounted to US\$ 3,457,100 (Details are at **Annex L**).

The uncommitted reserves for the TILF Special Account as of 31 August 2004 amounted to US\$ 5,165,200 (Details are at **Annex M**).

#### 5. Forecast

The Secretariat presented the forecast of Administrative and Operational account budgets for 2006-2008 to the BMC. The BMC agreed that the total amount to be allocated to 2005 projects should continue to be capped at US\$2 million of which up to US\$736,166 should be set aside for urgent 2005 projects. The BMC agreed that a prudent financial management approach should continue be adopted for 2005, but beyond that year there was a need to look afresh at the taskings for the Secretariat, the value of Operational Account projects to be funded and Members' contributions. The Secretariat is now assisting the BMC and Members to develop a sustainable financial strategy beyond 2005.

#### Service III: Management Support

#### **Staffing**

On 5 January 2004, the Secretariat welcomed Ambassador Choi Seok Young of Korea as the new Deputy Executive Director.

Secondees who joined the Secretariat as Directors (Programme) since Ministers last met were Ms. Monica Ochoa Palomera of Mexico, Mr. Soonthorn Chaiyindeepum of Thailand, Mr. Park Doo Soon of Korea, and Mr. Atsushi Iwasaki of Japan.

The Secretariat bade farewell to Ambassador Piamsak Milintachinda and Mr. Chutintorn Gongsakdi of Thailand, Mr. Kang Jae Kwon of Korea, and Mr. Masanori Wada of Japan.

The Secretariat has coped well with the changes and measures have been taken to minimise any impact that regular staff transitions may have on Secretariat support to member economies and fora.

The attrition rate of the support staff remains low. Their dedication and loyalty provide valuable support and continuity to the Secretariat. One Clerical Officer recruited in October 2003 for the Secretariat's Finance Section left in July 2004 for personal reasons. A replacement was appointed in October 2004.

#### **Incentive Schemes for Support Staff Members (SSM)**

The Secretariat is committed to provide an environment that is caring and forward looking, one that would promote professionalism and enhance staff morale. It is the Secretariat's hope that a sense of well being and job satisfaction would evolve through ongoing efforts in this direction, thus increasing productivity. Consistent with this approach, the Secretariat introduced the several staff incentive schemes and pro-family measures in 2004:

- <u>Ideas Incentive Scheme</u> aimed at encouraging SSMs to continually think of ways to do things better and more effectively;
- <u>Study Sponsorhsip Scheme for Support Staff</u>, an incentive tool for deserving SSMs, which is also a staff development tool enabling the Secretariat to benefit from better-trained staff;
- <u>Child Medical Leave</u> and <u>Childcare Leave</u> schemes, whereby married SSMs may take leave to look after their sick children below 12 years old or spend time with their children below 7 years old; and
- <u>Aged Parent/Parent-in-Law Medical Leave</u> scheme, whereby SSMs may take leave to look after aged parents (70 years old and above) when the latter fall ill or need to be accompanied to the hospital/clinic for medical check-ups.

#### **APEC Secretariat Internship Framework (ASIF)**

The Secretariat is looking into the implementation of an internship programme which would provide it with the services of qualified persons specialised in various professional fields. It would not have any financial implications for the Secretariat as all expenses connected with the internship, including accommodation and travel, will be borne by the intern and/or his/her sponsoring institution.

#### **Improving the Functioning of the APEC Secretariat**

The Secretariat continues to work towards improving the functioning of the Secretariat through the ISO process. The Secretariat's ISO Committee, in consultation with the Management Review Committee, regularly monitors and reviews the Secretariat's objectives to ensure that it is meeting stakeholders' expectations and that its services are

delivered with professionalism, diligence and transparency. In line with this process of continuous improvement and renewal, the Secretariat has increased the Service Satisfaction Index (SSI) from 70% to 80%, with effect from September 2004, as the Secretariat's average SSI of 78.6% for the past year was well above the target of 70%.

In addition, the ISO Committee has included the following new quality objectives with effect from September 2004:

- BMC pre-meeting project papers to be uploaded to website 10 days before the meeting.
- Substantive (papers requiring decisions) Secretariat papers for SOM/BMC to be submitted at least 10 days before the meeting

The Secretariat continues to review its Operational Manual to ensure that its policies, procedures and guidelines remain relevant. This is an ongoing process.

#### Service IV: Secretarial and Administrative Services

#### **Training Courses for Secretariat Staff**

The Secretariat is committed to provide staff with opportunities for self-improvement and life-long learning. Both SSMs and PSMs have been sent, or will be sent, to attend courses aimed at enhancing their performance, and/or contribute towards self-development, including:

- 1. ISO 9001:2000 Appreciation and Interpretation;
- 2. IT-related courses including IT Best Practices, Outlook 2003;
- 3. Self-development courses including Communications Skills, Work Management, Stress Management, Creativity and Innovation, Coping with Internal and External Customers, Leadership and Management Skills for Support Personnel, etc.

#### **Meetings at the APEC Secretariat**

Six meetings were held at the Secretariat building in 2004, as follows:

- 1 Budget & Management Committee Meeting I, March 2004
- 2 Counter-Terrorism Task Force (CTTF) meeting to agree on CT deliverables for presentation to Leaders July 2004
- 3 Energy Working Group's Trans-ASEAN Gas Pipeline Workshop, August 2004
- 4 Budget & Management Committee Meeting II, August 2004
- 5 Electronic Commerce Steering Group's Internet Investigatory Training Workshop for Law Enforcement Personnel, August 2004
- 6 27<sup>th</sup> Industrial Science & Technology Working Group Meeting, September 2004.

The Secretariat provided support services to the abovementioned meetings –assistance in obtaining hotel quotations and reservations, coordinating with meeting organisers on logistical requirements – stationery items, office/IT and audio-visual equipment, Less Paper Meeting System, if required, food catering, transportation, etc.

The SELI Symposium on International Financing Instruments is scheduled to be held in the Secretariat in December 2004.

#### **Visits Hosted by the Secretariat**

On 1 May 2004, the Secretariat was honoured by the visit of H.E.President Ricardo Lagos of Chile. During a ceremony held in honour of the President, President Lagos outlined plans for APEC 2004 and the growing links between Chile and the Asia. President Lagos also took questions from media in attendance at the news conference. The delegation accompanying President Lagos included Minister of Finance, Mr. Nicolás Eyzaguirre, and SOM Chair 2004, Mr. Ricardo A Lagos.

The Secretariat had earlier, in February 2004, hosted H.E. Vice President Arturo Vallarino of Panama. Vice President Arturo Vallarino was briefed by the Secretariat on APEC in general and APEC membership issues, in particular.

Through the year, the Secretariat hosted several personalities and groups as part of its ongoing interaction with officials from member economies, as well as its outreach programme. They include the following:

# **Introduction**

The APEC Secretariat was established in February 1993.

Singapore was selected as its site at the 4<sup>th</sup> APEC Ministerial Meeting in September 1992 in Bangkok.

The permanent site of the APEC Secretariat at 35 Heng Mui Keng Terrace was officially opened on 6 September 2003.

The Bangkok Declaration on Asia-Pacific Economic Cooperation (APEC) Institutional Arrangements determined the principal functions, financial arrangements and staffing of the Secretariat. Refinements were made in 1995 in the Report of the Task Force For the Review of the APEC Secretariat and the 1996 and 1997 Reports of the Task Force on Management Issues. The 14<sup>th</sup> APEC Ministerial Meeting in October 2002 in Los Cabos, Mexico welcomed the Report on Improving the Functioning of the APEC Secretariat, took note of the recommendations therein and supported their prompt implementation.

From an initial complement of 11 professional staff seconded from among the then 15 member economies, the Secretariat has grown to number 22 professional staff seconded from among the current 21 member economies.

The Secretariat's support staff totals 27.

The position of Executive Director is filled on secondment from the member economy chairing APEC. The position of Deputy Executive Director is similarly filled by the economy chairing APEC the following year.

# **Vision Statement**

To support and facilitate the achievement of APEC goals.

# **Statement of Business**

The Secretariat is the core support mechanism for the APEC process.

The Secretariat provides advisory, operational and logistical/technical services to member economies and APEC fora to coordinate and facilitate the conduct of business of the forum.

On behalf of member economies, it provides preparatory advice on formulation of APEC projects, manages project funding and evaluates projects funded from the APEC Operational and TILF Accounts.

The Secretariat provides coordination and support for APEC's communications and outreach programs and promotes understanding and support of APEC's role and agenda through a range of targeted communications activities which include print and web publishing, media, promotional and information services, and outreach to business and other stakeholders.

The Secretariat maintains a capacity to support research and analysis in collaboration with APEC Study Centres and PECC as required.

The Executive Director is responsible to APEC Senior Officials through the SOM Chair and manages the Secretariat in line with priorities set by SOM on behalf of Ministers. The Secretariat acts on behalf of APEC member economies as and when required or directed.

# **Annual Operational Priorities and Accountability**

APEC's operational priorities and activities are established annually by Leaders' and Ministers' tasking directions to Senior Officials. APEC Senior Officials manage activities and may adjust priorities on behalf of Ministers in the course of the year.

The Executive Director is responsible to Senior Officials through the SOM Chair and manages the Secretariat in line with priorities determined as above. Secretariat staff are responsible to the Executive Director for fulfilment of their respective responsibilities.

The Executive Director will provide performance accountability statements to SOM, as purchaser of Secretariat outputs, at its periodic regular meetings and also annually to Ministers.

The Executive Director will also provide relevant reports to the Budget and Management Committee (BMC).

#### 1. Overview

For the 10 month period from January to October 2004, the APEC website received a total of 24,242,797 requests.

The APEC website underwent major redevelopment in 2003 and the revamped site was launched in August 2003. Two of the key improvements to the APEC website included the consolidation of content suitable for a broad range of audiences as well as the eradication of duplicated and redundant content.

The total estimated number of visitors to the APEC website for 2004 is 323,375, as compared to 309,054 in 2003 and total data transferred in 2004 is 189.658 GB, as compared to 164.776 GB in 2003.

In 2002 a formal feedback process was instituted to enable ABAC to be informed regularly of action undertaken by APEC in response to its annual recommendations to APEC Leaders.
