Proposed Work Plan for 2016: Ocean and Fisheries Working Group

1. Proposed Work Plan for 2015 in Response to Leaders/Ministers/SOM/SCE Priorities and Decisions, and to ABAC recommendations.

In 2016, the Ocean and Fisheries Working Group (OFWG) will conduct a sequence of initiatives that aim to respond to APEC Leaders' Declarations, Ministerial and High-Level statements, decisions of Senior Officials, as well as SCE priorities and, where appropriate, ABAC recommendations. The OFWG will continue to implement the Seoul Oceans Declaration (2002), the Bali Plan of Action (2005), the Paracas Declaration (2010), and Xiamen Declaration (2014).

The initiatives to be taken sit within the framework of the OFWG Strategic Plan (2016-2018), which establishes 7 priority areas:

- 1. Free and Open Trade and Investment
- 2. Sustainable Development and Protection of the Marine Environment
- 3. Food Security
- 4. Climate Change
- 5. Natural disaster/Emergency Preparedness/Disaster Resilience
- 6. Blue Economy
- 7. OFWG Operations

The OFWG will hold two meetings in 2016:

- OFWG 6 in May in Arequipa (during SOM2)
- OFWG 7 in September in Piura (during APEC Food Security Week)

Through those meetings, its intersessional work, and its projects, the OFWG will:

- 1.1. Respond to Peru's Host Year priority for 2016 for the creation of a 'Regional Food Market'
- 1.2. Take actions to implement relevant actions under the 2015 APEC High-Level Policy Dialogue on Food Security and Blue Economy's Plan of Action.
- 1.3. Strengthen the role of sustainable fisheries and sustainable aquaculture in food security and related trade, including the promotion of inclusive growth strategies, and combating IUU fishing;
- 1.4. Promote responsible fishing industry and open and fair trade for small scale fishers and fish farmers to be integrated into the global food chain;
- 1.5. Promote Blue Economy relevant cooperation on the basis of the OFWG common view on Blue Economy;
- 1.6. Carry out ecosystem-based management approaches and programs, to ensure the effective sustainable management of coastal and marine environment including biodiversity:
- 1.7. Increase collaboration, develop integrated strategies on the impact of climate change;

- 1.8. Develop a Manual on Good Practices to Improve the Supply Chain of marine products aiming to maintain health of the fish stock, strengthening food security and enhancing trade in the Asia Pacific Region;
- 1.9. Promote enhanced capacity building through further OFWG projects. The group will also explore opportunities for developing self-funded projects;
- 1.10. Continue working to enhance coordination with other APEC sub-fora and refining efforts to mainstream ocean issues, including through participation in the Mainstreaming Ocean-related Issues Steering Council.
