1. Updates on SCSC 2016 Priorities

- ➤ Outcome: The Chair briefed on the progresses of SCSC works in align with SCSC 2016 Priorities and confirmed the significances.
- ➤ Next Step: Continuation on works leading to SCSC 1 in 2017.

2. First Policy Discussion

- > Outcome: The members discussed on 6 topics intensively.
- ➤ Next Step: Continuation towards next meeting (SCSC 1 in 2017), develop the outcomes for publication possibly in long term.

3. APEC Model Wine Certificate

- ➤ Outcome: Endorsed at SOM2 and reported at SCSC2.
- Next Step: Members to proceed its active utilization (continuously).

4. 21st Joint Regulatory Advisory Committee (JRAC)

- ➤ Outcome: Exchanged information on Electrical and Electronic Equipment (EEE) regulations and conditions for mutual recognitions.
- ➤ Next Step: Continuation towards 22nd meeting in 2017.

5. <u>Projects</u>

- ➤ Outcome: Shared information on implemented/on-going/future projects.
- ➤ Next Step: Members continuously working actively on projects in align with SCSC activities.

- To apply the ISO 14051 / Material Flow Cost Accounting ("MFCA")
- To transfer capacities to industries, standard practitioners and policy-makers
- To raise awareness among SMEs
