# Aligning funding and programmes to strategy

- EECA is partly funded by an electricity efficiency levy
- This is being broadened to cover other energy sources from the 2017/18 year.
- The levy, which has been collected from the electricity industry through the electricity efficiency levy, will now include funding through the Petroleum and Engine Fuels Monitoring Levy (PEFML), and the Gas Levy on piped natural gas that funds gas safety activities.
- This will allow EECA greater flexibility to pursue activities in the target transport and process heat areas.



#### **Electric Vehicles programme**

- Collaborative cross government programme. EECA is leading portions of this, such as information website and contestable fund of up to \$6 million per year to encourage and support innovative low emission vehicle projects

#### measures

- Projects are underway to update the MEPS in Air conditioning and building chillers, commercial refrigeration, domestic refrigeration,
- New MEPS on some lighting products (LED lighting/commercial luminaires) and industrial fans.
- Focus on harmonisation New Zealand works closely with Australia on equipment energy efficiency programme, and look to harmonise where possible with international standards.
