Explanatory Note

Background

- 1. In 2021, the APEC Group on Services developed a non-binding and non-exhaustive Reference List of Environmental and Environmentally Related Services (the "Reference List").
- 2. The Reference List was subsequently endorsed by Ministers at their 2021 Annual Ministerial Meeting.
- 3. The Reference List forms the basis of the Model Schedule of Commitments set out below ("Model Schedule").

Purpose and use of the Model Schedule

- 4. The purpose of the Model Schedule is to assist APEC member economies develop a positive list schedule of Environmental and Environmentally Related Services based on the Reference List.
- 5. Member economies may wish to use the Model Schedule in one of two ways:
 - a. to develop a standalone Schedule of Commitments for Environmental and Environmentally Related Services: a standalone Schedule of Commitments could sit as a supplementary Schedule of Commitments alongside a pre-existing Schedule of Commitments in a free trade agreement (for example, it could be added during negotiations for an upgrade of an existing agreement), or it could be tabled as a freestanding Schedule of Commitments for Environmental and Environmentally Related Services during negotiations for a new agreement; or
 - b. to insert new commitments into an existing Schedule of Commitments: in this case, the Model Schedule can assist an economy to identify sectors and sub-sectors in respect of which it wishes to insert commitments into a broader Schedule of Commitments in an existing or new free trade agreement.

How the Model Schedule works

- 6. The Model Schedule is designed to allow APEC member economies to follow the same positive list scheduling practice as they have followed in the GATS and other agreements that take a positive list approach to trade in services.
- 7. The Model Schedule uses the classification structure followed in the World Trade Organization (WTO)'s Services Sectoral Classification List (W/120). It

uses the headings for those sectors and sub-sectors which include environmental services and environmentally related services as identified in the Reference List. It includes cross references to relevant United Nations CPC categories (both Provisional and Version 2.1 are included).

Types of services

- 8. The Reference List divides Environmental and Environmentally Related Services into two groups:
 - a. **Group 1**: services that are environmentally related of themselves, being directly related to environmental conditions; and
 - b. Group 2: services that may be environmentally related when used for the design, construction and operation of certain facilities or equipment intended to improve environmental conditions, or for purposes that are determined to be environmentally beneficial by competent regulators (for example, with respect to projects related to renewable energy, pollution abatement, wastewater management, etc.).
- 9. In the Model Schedule, services subsectors that fall within Group 2 in the Reference List are marked with **an asterix** (*). When an economy makes a commitment in respect of these subsectors, that commitment will only apply in respect of services and service suppliers to the extent that the scheduling economy considers that the services are to be used for the purposes identified in the Group 2 definition. In other words, commitments will only apply to services and service suppliers if the services being supplied meet the Group 2 definition of "environmentally related". If services are used for other purposes, the economy's commitments will not apply in respect of those services or the service supplier.
- 10. For the purposes of accurately scheduling specific subsectors, some minor stylistic amendments have been made to the Reference List. These are noted in footnotes where they occur, and do not alter the substance of what has been agreed in the Reference List.

Relationship with pre-existing service commitments

11. Improving pre-existing commitments: In some cases, an APEC member economy wanting to make commitments in one of the identified environmental sub-sectors will already have pre-existing commitments in a relevant sector, but there may be conditions or limitations attached to those pre-existing commitments; or the pre-existing commitments may not apply to all modes of supply. The economy may use their new (or amended) schedule to improve their pre-existing commitments by removing the conditions or limitations for the

relevant environmental or environmentally related sub-sector, or making commitments for additional modes of supply for the environmental or environmentally related sub-sector.

For example, an economy may have already scheduled commitments in respect of "Architectural services". This commitment captures subsectors under the relevant CPC code (CPC Prov. 8671, CPC 2.1 8321). However, they may have entered conditions or limitations with respect to those services, or may not have made full commitments for each mode of supply. They may now wish to schedule additional commitments in respect of "Architectural services related to improvement of energy efficiency" and would do so by listing this sub-sector and scheduling the new or improved commitments they wish to make for it. These new or improved commitments will only apply to the sub-sector, "architectural services related to improvement of energy efficiency", and will not affect the remainder of the sub-sectors captured by their pre-existing commitment.

12. Scheduling sub-sectors not previously scheduled within a sector: In other cases, an APEC member economy may have already scheduled commitments in respect of one or more sub-sectors, but not those included in the Reference List. They may use their new schedule to list the newly committed environmental sub-sector.

For example, an economy may have already scheduled commitments in respect of "engineering design services for the construction of foundations and building structures (CPC Prov. 86722)" and "engineering design services for mechanical and electrical installations for buildings" (CPC Prov. 86723)". These are both sub-sectors of "Engineering services (CPC Prov. 8672)". They may now wish to schedule commitments in respect of "Engineering services for wastemanagement projects (hazardous and non-hazardous) (CPC Prov. 86729)" and would do so by listing this sub-sector and scheduling the commitments they wish to make for it. These new commitments would not affect the pre-existing commitments which would continue to apply to the other sub-sectors already listed.

13. Putting conditions or limitations on pre-existing commitments: Where an APEC economy is using the Model Schedule to add to commitments in an existing free trade agreement, they will not be able to put in place any new conditions or limitations on pre-existing commitments unless this is permitted under the terms of the agreement and, where relevant, is agreed with the other Party to the agreement. This will include situations where they wish to limit access in respect

of sectors or sub-sectors already committed so that their commitments only extend to the environmentally related portion of those sectors or sub-sectors.

For example, an economy may have a pre-existing commitment in respect of "engineering services for power projects (CPC Prov. 87629; CPC 2.1 83324)". However, they may now wish to limit that commitment so that it only applies to power projects deemed to be environmentally beneficial. They would not be able to put that limitation in place without reaching agreement with their trading partner who is the beneficiary of that commitment, otherwise they would be breaching the pre-existing commitment which applies to "engineering services for power projects" irrespective of the environmental benefits.

Horizontal limitations

14. Economies should consider whether horizontal conditions or limitations are relevant (such as overseas investment screening requirements or conditions related to the purchase of land). If they are scheduling new sectors or subsectors in the context of an existing agreement, they may wish to make a cross-reference to such conditions or limitations, or they may wish to replicate them as appropriate if they are tabling a supplementary Schedule of Commitments.

Annex 1 – relationship of the Reference List services to the WTO Services Sectoral Classification List

15. Annex I provides further assistance to Member economies by setting out the WTO Services Sectoral Classification List (W/120 List) and inserting the APEC Reference List of Environmental and Environmentally Related Services. This is provided to assist Member Economies for information purposes only to assist in seeing how the Environmental and Environmentally Related Services fit into the structure that has been used for GATS Schedules. The Model Schedule is based on this structure.
