#### EGILAT's Multi-Year Strategic Plan 2023 - 2027

#### 1. Introduction

The Experts Group on Illegal Logging and Associated Trade (EGILAT) was established in 2011 in response to statements, decisions, and priorities of Leaders and Ministers of the Asia Pacific Economic Cooperation (APEC).

Forests and forest resources provide critical economic, social, and environmental benefits for APEC economies and the world as a whole. Based on Food and Agriculture Organization of the United Nations (FAO) data, in 2020 APEC economies accounted for approximately 54.5% of the world's forests<sup>1</sup>. APEC economies contributed 43% of global forest products and 41% of the global trade in forest products valued at over \$344 billion in 2019<sup>2</sup>.

It is recognised that many APEC economies continue to face significant challenges from illegal logging<sup>3</sup>, and associated trade.

The goal of EGILAT as referred in its Terms of Reference is to enhance the efforts of member economies to take concrete steps to combat illegal logging and associated trade, promote trade in legally harvested forest products, and support capacity building activities in member economies.

The EGILAT will contribute to the achievement of the APEC Putrajaya Vision 2040, including through the implementation of the Aotearoa Plan of Action, for an open, dynamic, resilient and peaceful Asia-Pacific community:

# APEC PUTRAJAYA VISION 2040:

"Our Vision is an open, dynamic, resilient and peaceful Asia-Pacific community by 2040, for the prosperity of all our people and future generations"

**Trade and Investment:** "We acknowledge the importance of, and will continue to work together to deliver, a free, open, fair, non-discriminatory, transparent and predictable trade and investment environment"

**Strong, Balanced, Secure, Sustainable and Inclusive Growth**: "We will promote economic policies, cooperation and growth which support global efforts to comprehensively address all environmental challenges, including climate change, extreme weather and natural disasters, for a sustainable planet.

APEC's commitment to work towards the sustainable resource management of forestry and to combat illegal logging and associated trade is stated in the Aoteaora Plan of Action.

#### Aotearoa Plan of Action:

"Work towards the sustainable resource management of agriculture, forestry and marine resources and fisheries, including by implementing the APEC Roadmaps on Marine Debris, and Combatting Illegal, Unreported and Unregulated (IUU) Fishing, and commitments to combat illegal logging and associated trade"

The EGILAT Multi-Year Strategic Plan 2023-2027 is intended to guide its work over the next five years. It takes into account the work previously undertaken by the group as part of the EGILAT Multi-Year Strategic Plan 2018-2022, including the information and views exchanged in EGILAT Meetings and associated events held during this period.

During the period of the Multi-Year Strategic Plan 2023-2027, EGILAT will continue to focus its efforts on combating illegal logging and associated trade within the APEC region, promoting the trade in legal forest products. This work will be in line with the principles of EGILAT's Terms of Reference, the relevant Statements, decisions, and priorities of APEC Leaders' and Ministers' directives.

# 2. Vision Statement

EGILAT seeks to enhance the efforts of its member economies to take concrete steps to combat illegal logging and associated trade, promote the trade in legally harvested forest products, and support capacity building activities in member economies, according to the EGILAT's Terms of Reference, and thereby contribute to the achievement of the APEC Putrajaya Vision 2040 including through the implementation of the Aotearoa Plan of Action, for an open, dynamic, resilient and peaceful Asia-Pacific community.

# 3. Mission Statement

EGILAT's mission is to foster a strong, balanced, secure, sustainable and inclusive growth in the Asia-Pacific region by enhancing the efforts of member economies to take concrete steps to combat illegal logging and associated trade, promote the trade in legally harvested forest products and support capacity building activities in member economies.

# 4. Critical Success Factors 2023-2027

EGILAT's ability to achieve its mission established in the Multi-Year Strategic Plan 2023-2027, depends on the following factors:

- Facilitating and strengthening cooperation and information sharing related to combating illegal logging and associated trade;
- The active participation of trade, forestry and other relevant officials of the APEC member economies in EGILAT's work;
- Identifying capacity building needs and finding, where possible, necessary resources to effectively implement actions for this purpose;
- Increasing the level of knowledge of APEC member economies on the scale and nature of illegal logging and its associated trade within the APEC region, and the benefits of the trade in legally harvested forest products and sustainable forest management, as it relates to EGILAT's goal. ;
- The willingness and commitment of APEC member economies to take actions to address identified problems;
- Capacity of member economies to take concrete steps to combat illegal logging and associated trade and promote trade in legally harvest forest products is enhanced.
- Engaging with relevant APEC fora whose work interacts with and complements EGILAT's objectives;
- Engaging and encouraging the active participation of industry, civil society, and relevant international and regional organisations in EGILAT meetings and other events to raise awareness of, and contribute to, EGILAT's activities;
- Facilitating and strengthening law enforcement cooperation and information sharing related to combating illegal logging and associated trade, consistent with domestic law and in accordance with applicable international agreements;
- Sharing of information regarding policies, laws, and regulations in APEC economies to combat illegal logging and its associated trade, promoting the trade in legally harvested forest products,
- Collaborating with international and regional forestry organisations working on sustainable forest management and rehabilitation, where appropriate, and endeavouring to ensure that EGILAT's activities complement and do not duplicate activities being carried out in those organizations;
- The support of APEC, through its funding initiatives and the work of the Secretariat.
