### **Emergency Preparedness Working Group's Proposed Workplan for 2020**

#### Introduction

In 2020, the Emergency Preparedness Working Group will continue to focus on enhancing resilient trade and investment through promotion of the APEC Disaster Risk Reduction (DRR) Framework adopted by the Leaders in 2015 to address the "new normal," by implementing the 2016 APEC Disaster Risk Reduction Action Plan.

In line with EPWG 2017-2020 Strategic Plan and APEC DRR Framework, EPWG will fully support the 2020 Malaysia's theme of "Optimizing Human Potential Towards A Future of Shared Prosperity" with its three policy priorities namely (1) Improving the narrative of trade & investment, (2) Inclusive Economic Participation through digital economy & technology, and (3) Driving innovative sustainability. In recent years, urbanization and mega-city agglomeration in APEC economies have led to high exposure of urban areas to disasters. Therefore, their vulnerabilities and losses to disasters have also been more obvious which has been a major obstacles for sustainable development. Therefore, in the age of increasingly advanced regional integration, how to help people living in this interwoven city network to copy with disasters could be a necessity task for EPWG. As we proposed the priority of improving the narrative of trade, regional integration in this region should be defined and advanced not only for the benefit of economies but also for the people that drive the region's growth. As such, APEC should expand its growth story through the lens of disaster resilience to include a vision of economic integration that felt at all levels and leaves no one behind, namely, from the grassroots to decision-making level, and from business communities to knowledge groups. To achieve those priorities, it would require a risk-informed and adaptive disaster-resilient city in APEC economies. The vision of EPWG should thus be widely shared among economies for our future development. In that regard, the EPWG will align its work with the 2020 priorities of Malaysia to promote Sustainable and inclusive Growth by activities that will be conducted by EPWG in 2020.

EPWG will also implement the task as mandated by the 2017 AELM Declaration paragraph 27 and 2017 AMM Statement paragraph 42 as follows:

- Strengthen cooperation by a multi-stakeholders participant approaching, including with the government agencies, academy, business, private sector and public, to enhance resilience to disasters through effective and efficient mitigation, preparedness, disaster risk reduction, response and recovery efforts; underlining the importance of financial instruments and policies against disaster risks.
- Implement the APEC Disaster Risk Reduction Framework Action Plan with emphasis on cooperation in capacity building, early warning systems, disaster risk identification, assessment and monitoring, risk financing policies and instruments including insurance, mitigation, search and rescue, and post disaster recovery assistance.

EPWG will also ensure cross-fora collaboration in particular with regard to the implementation of the APEC DRR Action Plan.

Hold Workshop on Enhancing Participation in Flood Disaster Preparedness through Community- based Hazard Mapping – Malaysia	Community participation is one of seven enabling environments for the four pillars of the APEC Disaster Risk Reduction Framework. The project aim is to enhance community participation in disaster preparedness.  The project will be implemented with two Malaysian NGOs, Malaysian Water Partnership (MyWP) and Global Environment Centre (GEC), as well as the National Disaster Management Agency (NADMA) and Department of Irrigation and Drainage. The "Machizukuri" or "Town watching" method (advocated by Asian Disaster Reduction Centre) will be used. Hold 1960–2010: Understanding the past and preparing for a better future. Lessons and new developments in Seismic Monitoring and Tsunami Threat Assessment - Chile	On May 22nd 1960, the largest Earthquake ever recorded struck Chile, causing a Tsunami that spread across the Pacific, emphasizing the need for a coordinated Tsunami Warning System. In 2010 another large Earthquake in Chile, showed that this system could be improved.  In 2020 as a commemoration of 60th and 10th anniversary of the 1960 and 2010 Earthquakes, this project will fund a Workshop to be held during 2020 to address the lessons learned and the developments in Seismic Monitoring and Tsunami Threat Assessment.  The workshop will stress the importance of cooperation, capacity building, as well as the significant impact of data sharing. Hold the Self-funded Project "Regional economic integration through the lens of disaster resilience" in China	In the age of urbanization and regional economic integration, growing disasters and risks may adversely affect APEC cities and citizens. The project will highlight both the necessity of better risk identification, assessment and transfer in cities and the importance of enhanced risk awareness among government departments, business communities and the general public.  First, to achieve better risk identification, assessment and transfer in cities, case study and collection will be conducted, APEC Workshop on Better Disaster Risk Monitoring and Assessment for A Risk-informed Regional Integration will be held, and a regional standardized methodology or tool for risk assessment is on our agenda.  Second, interconnected supply and demand chain was born in the process of regional integration, which in turn may be disrupted by challenges from the integration, for example, vulnerability to disasters. So a risk-smart business model will be encouraged.  Third, though differentiated disaster reduction measures are needed to suit local conditions, the value of indigenous experience should be recognized, highlighted and maximized. Each member economy will be encouraged to share knowledge on this topic through 1-2 short videos. Chinese Taipei proposed "APEC Resilient City" (ARC) initiatives to carry on the fruitful outcomes of "Plant Back Better" initiatives for mitigating vulnerability and enhancing disaster resiliency through capacity building. The ARC initiative aims at capacity building and preparedness for quick recovery of micro economic activities through public private partnership. ARC initiatives incorporates the implementation of the best practices for sharing local knowledge and regional resources to facilitate Livelihood Continuity Plan (LCP) before or after disasters. It fully echoes the 2017 priorities "Enhancing Food Security and Sustainable Agriculture in response to Climate Change". ARC functioned to boost up micro economic momentum to tackle future challenges on climate change adaptation.

The 2020 APECRW will focus on 1) Sharing the best practices for APEC Resilient City/Community, 2) Sharing smart resilient city planning; 3) Promoting on demands capacity building program; 4) Showcasing female's contributions on ARC initiatives; 5) Synergizing regional resources for ARC.

The expected outcomes of the APECRW can be of good reference for developing future approaches toward ARC. The main expected outcomes include: 1) Enhancing public-private partnership on disaster resilient supply chain 2) Developing guiding principles for planning ARC, 3) Accelerating APEC cross-fora synergy on ARC and 4) encouraging APEC-wide implementations through cross-border value-added knowledge and best practices sharing for promoting ARC upon the APEC Disaster Risk Reduction Framework (APEC DRR Framework).
