	NEW Drug Development ParadIGmS (NEWDIGS)
10 min	The Massachusetts Institute of Technology's NEW Drug Development ParadIGmS (NEWDIGS) program is focused on enhancing the capacity of the global biomedical innovation system to reliably and sustainably deliver new, better, affordable therapeutics to the right patients faster. This session will focus on creating precision financing solutions and performance-based annuities to address financial challenges to therapeutics.

10 min	Chile's Ricarte Soto Fund The purpose of the Financial Protection System for High Cost Diagnoses and Treatments, also known as the 'Ricarte Soto Law (RSL)', is to provide coverage for certain high-cost health technologies to all beneficiaries of the healthcare systems in Chile. This session will discuss how the Ricarte Soto Fund is being used to increase access to innovative medicines in Chile.

	Italy's Innovative Drugs Fund for Cancer and other Innovative Therapies
10 min	In April 2017, two separate Innovative Drug Funds (for Innovative Oncology Drugs and for other Innovative Therapies respectively, € 500 Million each) were introduced by the Italian Ministry of Health to accelerate access to innovative therapies. Concurrently, a new algorithm was released under which the Italian Medicines Agency (AIFA) assesses the level of innovation provided by new therapies and their eligibility to be funded through this mechanism. In July 2021, the two Funds were unified (€1 Billion Fund for Innovative Drugs) and other measures are now being discussed at Government level.
	This session will cover how this Fund was created, how it is sustained, its impact on access to innovation and its role in the broader health financing context in Italy.
