## **ANNEX 7 - ACTION PLAN**

## Description of the current situation

As the result of the project's implementation there have been achieved a proved need for the development and further launch of a special Integrated Information System on the level of APEC economies that would support successful and efficient internationalization of the APEC SMEs.

It is highly important for this instrument to meet a range of the set criteria as well as to be flexible enough to secure its further development based on the new challenges, changing external environment and SME needs:

- it should be of multi-side character in order to secure participation / involvement of the maximum number of economies in its activities;
- it should be aimed at support of not only export but also import activities of SMEs, technological and scientific cooperation, establishment of joint ventures, investment attraction in order to stimulate internationalization process in general;
- it should be of an integrated character in order not only to provide contacts of potential business partners in this or that country but present reliable and trustworthy information on the legislation in the sphere of foreign activities, customs procedures, IPR protection, technical standards and requirements as well as offer consulting and organizational support;
- it should have unique center for management and coordination, monitoring and control activities to cooperate with national partners in order to provide one standard package of services and procedures, etc.

In order to develop and to launch the above mentioned Integrated Information System stimulating successful and efficient internationalization of APEC SMEs, it is necessary – within a limited period of time - to undertake a number of steps and actions with clear responsibility within Russia (the economy that is initiating the project) as well as within APEC Secretariat. Thus, it is necessary to develop and implement a special action plan to identify the interested parties / economies as well as sources of finance.

## Planning period

From time point of view implementation of the present Action plan could be consisting of two stages – short-term (1 – 2 years) and long-term (up to 5 years). It is clear that planning on the short-term stage will be of more detailed and operational character whilst planning on the long-term stage will be of strategic character and will highly depend on the results of the short-term stage.

The present Action plan covers the two years period based on the need to organize, prepare and implement a set of steps and actions to launch successfully the Integrated Information System.

## Responsibility

The Russian Federation Ministry of Economic Development will be responsible for interaction with APEC Secretariat as the federal body in charge of the support and development of the Russian SME sector as well as the official body introducing Russia during various APEC meetings and events.

Institutions / organizations responsible for implementation of various activities will be either selected by the RF MED on the tender basis or through some other procedures to be defined and agreed.

Serious interest to the development of IIS is paid by the Russian Federation Ministry of the Far East Development that is ready to become one of the main stakeholders.
